OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE IN THIS SWEEPSTAKES (DEFINED BELOW). VOID WHERE PROHIBITED BY LAW. INTERNET CONNECTION IS REQUIRED TO ENTER. THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DETERMINES THE ODDS OF WINNING.

BY ENTERING THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SPONSOR FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

THE SWEEPSTAKES IS NOT SPONSORED, ENDORSED, ADMINISTERED BY OR ASSOCIATED WITH ANY SOCIAL MEDIA ENTITY, INCLUDING BUT NOT LIMITED TO TWITTER AND DISCORD. YOUR USE OF TWITTER AND DISCORD IS GOVERNED BY TWITTER'S AND DISCORD'S PRIVACY NOTICE AND TERMS.

GENERAL

1. Eligibility

The Sweepstakes is open worldwide and is void where prohibited by law. Employees, officers, directors, members, managers, agents, and representatives of Sponsor, or their parent companies, divisions, subsidiaries, and affiliates (collectively, the "Sweepstakes Entities") are not eligible. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.

2. Sweepstakes Period

The first "Sweepstakes Period" begins at 7pm CET on March 27, 2022. There are four (4) individual Sweepstake Periods. Once a Sweepstake Period ends, the next Sweepstake Period

starts immediately. The duration of each Sweepstake Period is defined by a timer indicating the length.

3. How to Enter

During the Sweepstakes Period, to participate and enter this Sweepstakes, eligible individuals (“Entrants”) must complete ALL of the following steps (an “Entry”):

- Connect a Solana wallet to the website
- Authenticate user profile by connecting a Discord account
- Join the Knittables Discord: <https://discord.gg/knittables>
- Stake at least one Knittables NFT 24 hours before the respective Sweepstake Period ends

Entries that are incomplete or do not adhere to the rules or specifications of the Sweepstakes may be disqualified at the sole discretion of the Sponsor. You must provide the information requested. You may not enter more times than indicated by using multiple Discord accounts, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules of the Sweepstakes, your submission may be disqualified at the sole discretion of the Sponsor.

A Discord account is needed to complete an Entry. Establishing a Discord account is free. All applicable Discord terms and conditions apply.

Entrant’s Discord account must be a verified member of the Knittables Discord server (<https://discord.gg/knittables>) to participate.

4. Winner Selection

Each potential prize winner (“Potential Prize Winner”) will be chosen in a random drawing. The odds of winning for a participant depend on the number of eligible Entries received. All Potential Prize Winners will be selected within 3-4 days after each Battle (“Sweepstakes Selection Date”) from among all eligible Entries received.

5. Winner Notification

The potential Prize Winners will be notified by an announcement and a ticket on Discord (a "Winner Notification") on or shortly after the Sweepstakes Selection Date and will be required to respond to such direct message within 3 days.

To be eligible to receive a Prize, the potential Prize Winner must respond to the Winner Notification via ticket through Discord and provide a valid Solana wallet address. Accordingly, you might need a blockchain address and a third-party Solana wallet to receive a Prize.

If a selected potential Prize Winner cannot be contacted, is ineligible, fails to respond to the Winner Notification message in the time allotted and/or fails to timely provide the required documents listed above, or such documents are incomplete or modified, their prize may be forfeited, and an alternate winner may be selected from remaining valid, eligible entries. Sponsor reserves the right to modify the timing, selection, and notification procedures in connection with the selection of any alternate potential Prize Winner. Prize will be fulfilled within approximately one week of winner verification.

Upon prize forfeiture or inability to use a prize or portion thereof, no compensation will be given, and Sponsor will have no further obligation to that entrant. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized account holder of the Discord account specified in the entry.

6. Prizes

There will be a variety of prizes raffled through the Sweepstake Periods (NFTs, \$YARN, and other prizes). Actual/appraised value of Prizes may differ at time of prize award. The specifics of the Prizes shall be solely determined by the Sponsor. All federal, state and local taxes and any costs and expenses associated with Prize acceptance and use not specified herein as being provided are the responsibility of Prize Winners including, but not limited to, the transaction fee to mint and/or accept the NFT.

The Prize Winners will receive the Prize by providing their Solana wallet address when responding to the Winner Notification. By using your wallet in connection with receiving the Prize, you agree that you are using that wallet under the terms and conditions of the applicable provider of the wallet. The Prize Winner bears the sole responsibility for providing a correct and accurate Solana wallet address.

All Prize details will be determined in Sponsor's sole discretion. Sweepstakes Entities are not responsible for and will not replace any lost or stolen Prize or if the Prize is undeliverable or does not reach the Prize Winner because of incorrect or changed contact information. If the Prize Winner does not accept the Prize, the Prize will be forfeited and Sponsor will have no further obligation with respect to that Prize. Sweepstakes Entities are not responsible for any

inability of the Prize Winner to accept or use the Prize for any reason. No transfers or prize substitutions or cash redemptions will be made, except at Sponsor's sole discretion.

7. Licenses and Approvals

8. Limitation of Liability

Sponsor is not responsible or liable for (i) late, lost, delayed, damaged, postage-due, incomplete, illegible, garbled, misdirected or undeliverable Entries, tweets, responses, or other correspondence, whether by email, @replies, mail, or otherwise; (ii) theft, destruction, unauthorized access to or alterations of entry materials; or (iii) phone, electrical, network, computer, hardware, software program or transmission malfunctions, failures or difficulties or any technical hardware or software failures of any kind, which may limit a person's ability to participate in the Sweepstakes.

13. Disputes, Governing Law and Choice of Forum

14. General Rules

Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor's decisions will be final in all matters relating to the Sweepstakes, Sponsor reserves the right to restrict or void online Entries or participation from any IP address if any suspicious Entry and/or participation is detected. Sponsor reserves the right, in its sole discretion, to void Entries of any Entrants who Sponsor believes has attempted to tamper with or impair the administration, security, fairness or proper play of the Sweepstakes. In the event there is an alleged or actual ambiguity, discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials and/or these Official Rules (including any alleged discrepancy or inconsistency in these Official Rules), it will be resolved in Sponsor's sole discretion. Entrants waive any right to claim ambiguity in the Sweepstakes or these Official Rules. If Sponsor determines at any time in its sole discretion that Entrant is disqualified, ineligible, or in violation of these Official Rules, or engaging in behavior that Sponsor deems obnoxious, inappropriate, threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right in its sole discretion to select an alternate winner. The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. If the Sweepstakes is not capable of running as planned for any reason, Sponsor reserves the right, in its sole discretion, to cancel, modify or suspend the Sweepstakes and award the prizes from all non-suspect eligible entries received prior to cancellation, modification, or suspension or as otherwise deemed fair and appropriate by Sponsor. In the event of a dispute concerning who submitted an Entry, the Entrant will be declared to be the registered account holder of record for the account submitting an Entry during the Sweepstakes Period, but only if that person meets all other eligibility criteria, otherwise the Entry may be disqualified, and any potential Prize won will be forfeited in Sponsor's sole discretion.
